- (3) Are there any items today that are rationed by the government? Do you need to think carefully before purchasing or using any items in your life?

### APPLICATION FOR A SPECIAL SHOE STAMP

**IMPORTANT**  
**Read these instructions before filling in this form**

This application is to be used only by a person who would suffer serious hardship if he were unable to buy a pair of shoes in addition to his regular ration.

There are not enough shoes to give everyone all the shoes he wants, but there are enough for all who really need them. Stop and think, before you complete this form. Have you **any** shoes that will meet your needs? Do not make this application unless you can qualify under all **four** of the following rules:

- (1) You do not have a valid War Ration Shoe Stamp (or Special Shoe Stamp) and no member of your family has a War Ration Shoe Stamp that you can use.
- (2) No employer or institution furnishes you with shoes that will meet your needs.
- (3) The shoes are needed for occupational or general wear—not merely for maintaining personal appearance or for sportswear.
- (4) You have no more than one pair of shoes in wearable or repairable condition that will meet your needs.
